- Students seemed to be very convinced and satisfied by the use of ICT tools in the class room exercise by the teachers more effectively;
- Students are also satisfied with the remedial classes and mentor's role in attending the students' academic and other concerns;
- Students are seemed to have the concern about clarity of presentation, expression, language and the voice among the few teachers;
- Students had the concern about the availability of the teachers after the class hours for needful discussion on subjects and others;
- Students have pointed out the need for active learning methodologies like, group discussion, tutorials, assignments, seminars and field visits;
- It was clearly reflected in the feedback by the students that the overall conduct of examinations and evaluation process was so transparent and the assignments are graded so fairly.

The Vice-Chairman and the Principal highlighted the outcomes of the Student Satisfaction Survey during the meeting. Each of the teachers could make the specific note of the feedback analysis. It was advised during the meeting that the faculty shall take the serious note the student feedback and try to improve the areas were their weaknesses are pointed out.
