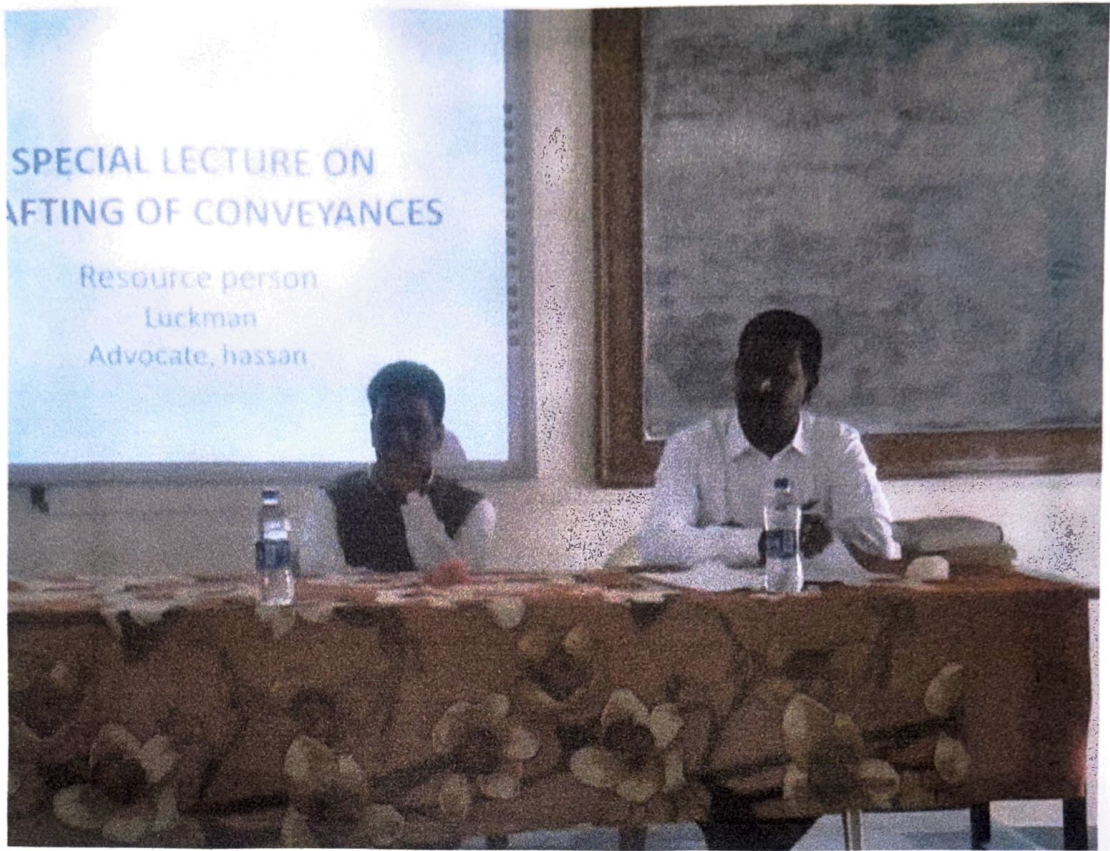
REPORT ON - SPECIAL LECTURE ON
