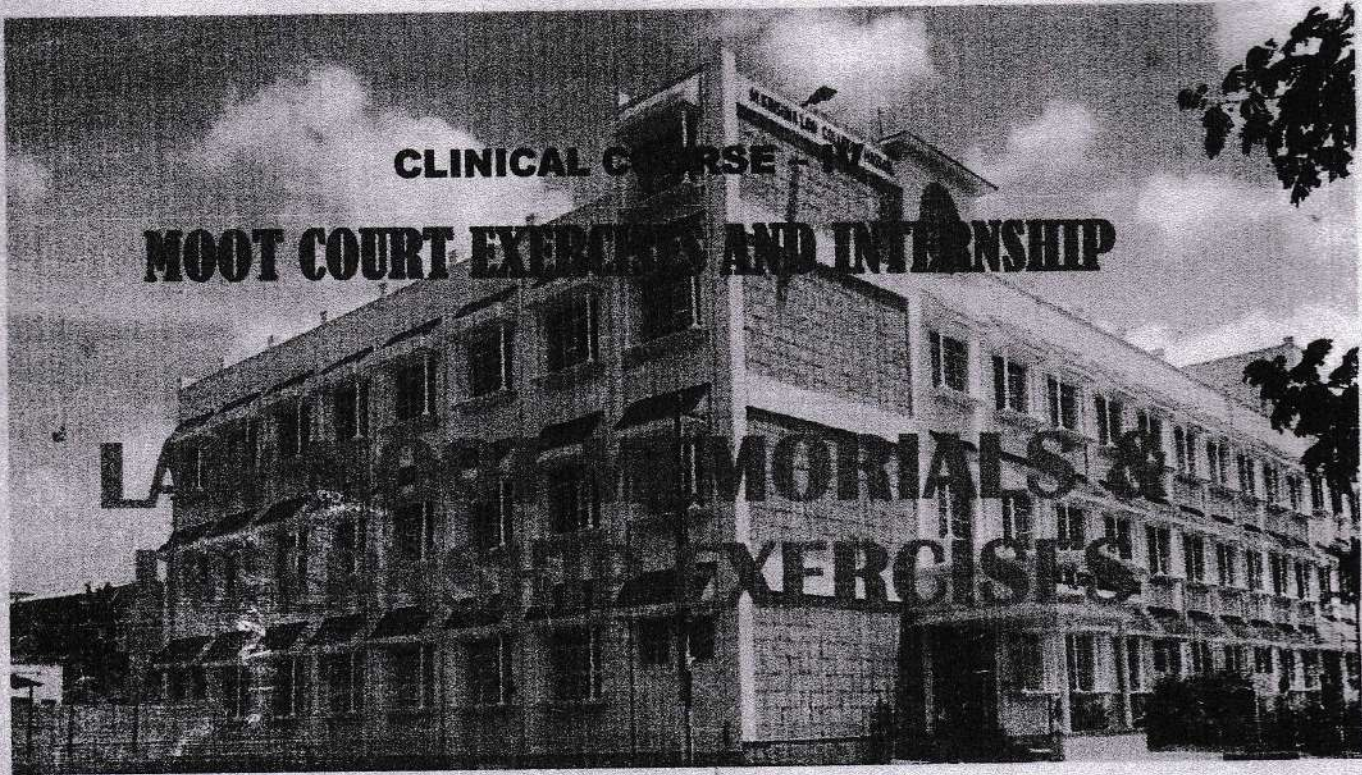



STATEMENT OF FACTS


1. Bino Joseph is a 26 year old man whose cerebral cortex was destroyed by lack of oxygen after an accident in 2020 who is in a permanent vegetative state being treated at Gayatri Hospital Bangalore. The doctors had said that recovery was impossible and Bino's parents are incurring hospital expenses of more than Rs. 1000/- per day.
2. Meanwhile in Dec 2022 Bino's younger sister Nancy, 15 years old had total kidney failure and only Bino's kidney was compatible for a transplant. Before the accident, Bino had written in his diary that he wanted to help needy people by donating his organs.
3. Bino's parents approached the doctors at Gayatri Hospital and requested to remove life support and donate the only kidney to his sister as further treatment was futile.

4. Bino's parents wanted to fulfill their son's wish to donate organs. But doctors refused to allow as Bino was not Brain Dead and violates provisions of Transplantation of Human Organs Act, 1994.

5. In January 2023 Mr. & Mrs Joseph approached the Supreme Court of India by filing a petition under Art 32 of Constitution of India against Gayatri Hospital, seeking court's permission to donate organs declaring it would be lawful and allow him to die. They said that this was in the patient's best interest and in protection of his rights to life guaranteed under Art 21. Union of India also joined as Respondent.

STATEMENT OF FACTS

1) Sara is a clinical social worker in emergency department of Private General Hospital located in the high-class area of Pune city, Maharashtra. The "ONP General Hospital" is well equipped and has services like Laboratory, Diagnostic and Imaging, Ambulance service and Intensive Care Unit.

On 26th May 2022, at about 10 am 15 year-old boy rushed to hospital by neighbors following apparent suicide attempt. The boy had consumed antidepressant medication & benzodiazepine.

2) The neighbors contacted his mother "single parent" Smt. Ajitha Mehta and reached hospital at 10:30 am. and met Sara who tried to help her cope with the crisis. Smt. Ajitha Mehta insisted to be with her son but was restrained by hospital staff.

3) During the episode, the mother was anxious and worried and everyone tried to calm her and wait for test reports.



In her fit of anger she was continuously blaming boy's father and he was responsible for boy's emotional distress and has never shouldered any responsibility in son's upbringing. The mother was also critical of boy's school counselor and should have shared more information about his distress and could seek medical help. Unfortunately boy died in few hours.

4) On 30th May 2022 while reading newspaper "Daily Mail" Ajita Mehra came across article on "Need & importance of Child Counseling in cases of single Parenting" written by social worker 'Shajet Singh' who quoted several examples, withholding real names and one incident was close to her son's incident and found that Shajet Singh was attached to ONP Hospital and had access to medical records.

5) Her colleagues, friends made calls for condolence and were mentioning about newspaper article and asked her to control her temperament and do meditation.

STATEMENT OF FACTS

- 1) Mr. Shah, a farmer living with his family consisting of his wife (Mrs. Rama), son Mr. Sohail, and daughter Ms. Sirisha.
- 2) Mr. Kiran, a boy living in the same village, was working as a data entry operator in a private company, 12 km away from village where Mr. Sirisha college is located.
- 3) Mr. Kiran ~~was~~ in love with Ms. Sirisha daughter of Mr. Shah. On 10th August, 2018 after knowing their relationship Mr. Shah warned Mr. Kiran to stay away and severely admonished and scolded his daughter to refrain from meeting Mr. Kiran.
- 4) Mr. Sohail owed a debt of Rs 50,000/- to Mr. Kiran which was taken for personal reasons. On August 17, 2018, Mr. Sohail called Mr. Kiran to his house to repay loan amount of Rs 50,000/- as full and final settlement. Mr. Sohail gave him Rs 50,000 and asked him to leave immediately.

5) While Mr. Kiran was about to leave the place Ms. Srisha hugged him from behind. Mr. Shah after seeing this rushed to his daughter and dragged her inside the house and bolted the doors from outside.

6) Mr. Shyam (brother of Mr. Shah) brought a lathi and started beating Mr. Kiran on his head and chest. Ms. Srisha managed to escape and rushed to protect her lover and received three serious blows on her head and collapsed unconscious. Both were taken to hospital, with the intervention of neighbours where Mr. Kiran survived but Ms. Srisha died after 10 days.

7) Post-Mortem Report confirmed she suffered injuries on head and one of these injuries independently was sufficient to cause her death, while they cumulatively were sufficient to cause death in ordinary course of nature.

8) First Information Report (FIR) was registered under Sec 154 of CrPc against Mr. Shyam, Mr. Shah, Mr. Sohail for death of Ms. Srisha and attempt to murder Mr. Kiran.

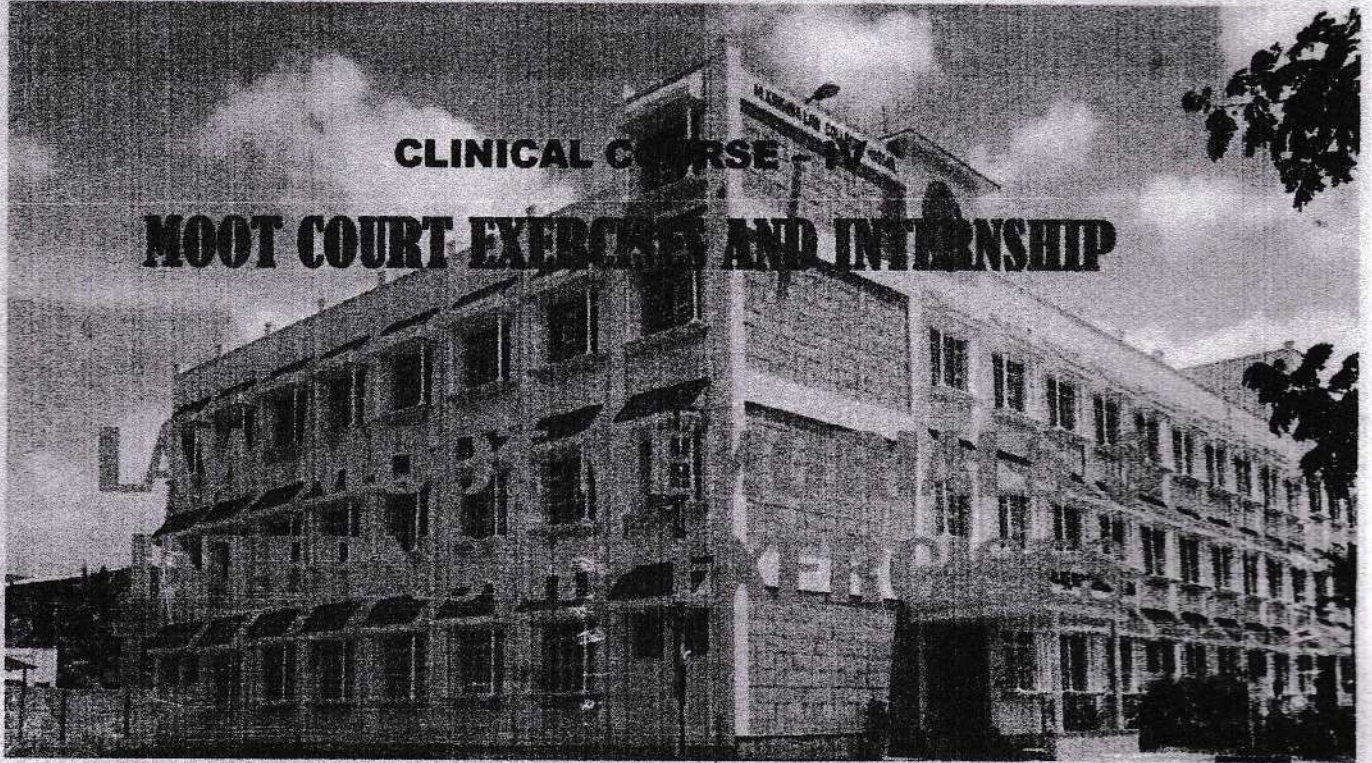
We visited the court to observe the proceedings of Lok Adalat on 8-07-2023.



STATEMENT OF FACTS

1. Bino Joseph is a twenty-six year old man whose cerebral cortex was destroyed by lack of oxygen after an accident in 2020. He went into a permanent vegetative state and was being treated at Gayathri Hospital in Bangalore.
2. He is being kept alive on feeding and hydration tubes since the last five years, incapable of any sensation or thought. The Doctors said that Bino Joseph could continue living like this for several years but were certain that recovery was impossible. Bino's parents are presently incurring hospital and medical expenses of more than ₹1000/- per day towards his treatment.

3. Before the accident, Bino had made a declaration stating that he wanted to donate his organs (Kidney & eyes). Writing in his diary, Bino said that he wanted to help needy people and God has given him the opportunity to donate his organs & he wanted to do that.

4. Meanwhile, in December 2022 Bino's younger sister Nancy who was a 15 years old had a total kidney failure and the doctors had suggested that a kidney transplant would have to be done. Upon having blood test done of all the family members, it was found that only Bino's kidney was compatible for a transplant. If Nancy did not receive a kidney transplant soon, there was grave danger to her life.

On August 17, 2018, Mr. Sohail called Mr. Kiran to his house to repay the loan amount of ₹50,000/- as full and final settlement. At about 8:30 pm Mr. Kiran came to Sohail's house & Mr Sohail gave 50,000/- to Mr Kiran & asked him to leave immediately.



1. "Durgaparameshwari Temple" wherein the idol of goddess Durga is worshipped, is situated in Kailash Township in the state of Peshwapur in India. The said Township is an abode for pilgrims and devotees as it consists of various other temples apart from the aforesaid Durgaparameshwari Temple. Every year the people of the township along with the Durgaparameshwari Temple Authorities conduct an annual festival wherein goddess Durga is placed in a chariot and a procession is taken, with much fanfare. The said festival has attracted devotees and tourists from all around the world.
2. The increase in the number of devotees and tourists to the Kailash Nagar Township has also increased corruption and harassment of the devotees and tourists at the hands of the temple authorities and aulakas. Further, the funds flowing into the temple also came to be mismanagement. The same has affected the religious sentiments of the devotees. The State Government having received complaints from the people with regard to the harassment and mismanagement of funds of the temple, decided to step in and

accordingly passed an Act, called the "Temple city Devasthanam Samrakshana Act 2023. The said Act came into force on 6-5-2023. The Act declared that henceforth Kailash Nagas would be called as the Temple city. The said Act extended to all the Temples situated in Temple city and notified in schedule A of the Act.

3. The aforesaid Act inter alia consisted of provisions for formation of a Board of management for the temples, which shall be responsible for the day to day functioning of the Temple and other functions of the temple and overall development of the township. Further as per section 16 of the Act all the archakas who perform pooja and carry out other religious duties in the temple have to get themselves compulsorily registered with the Board. Further, the Archakas have to pay the State Government a percentage of their income as development fee. The said section runs as follows:-

Section 16: Registration of Archakas.

- (1) All Archakas who perform pooja and other religious duties within the temple which has been notified under this Act have to get themselves compulsorily registered with the Board and shall pay to the state govt

4. Ashitha, in her plea averred that she has withdrawn from the society of her husband to seek employment which is her fundamental right and her withdrawal is for reasonable cause. She further pleaded that she has not deserted her husband rather husband deserted her and moved a counter petition in the District Court at Mysore that her husband is denying his society to her without reasonable cause and hence a decree for restitution of conjugal rights under sec-9 of the Hindu Marriage Act 1955 or in the alternate decree of judicial separation under section 10 be passed.

STATEMENT OF FACTS

1. Mr. Joe Cornell was a citizen of the Republic of Ordana, residing in Montawa, a city of State Tahoma. He was the chief Executive officer of a leading multinational company, Arin Technologies. Just like any other day, on 05.01.2001, Mr. Cornell had left home in his car at Nine a.m for his office. But he never reached there. Instead, at about one p.m. his wife, Mrs Osaka Cornell, received a call from the Station House Officer, Montawa Public Station, informing her that Mr. Cornell had been killed.
2. Mrs. Osaka Cornell lodged a complaint and the Station House Officer registered a First Information Report at Montawa Police Station (FIR NO 13/2001 was filed under section 302 and 201, Ordana Penal Code, 1860) She informed the police that her husband was wearing a white shirt, black trousers and a blue sweater. She also mentioned that Mr. Cornell was carrying his laptop when he left home.
3. Inspector Michad Watson prepared the seizure memo of items recovered from the place where Mr. Cornell was found murdered. No laptop was recovered. The deceased

was wearing white shirt and black trousers when his body was found sub-Inspector Hillary Duck prepared the inquest report under the instruction of Inspector Michael Watson. Thereafter Inspector Michael sent the dead body for a post-mortem with a constable. Dr Larry John conducted the post mortem of the body and found that the death of the deceased was a result of ante-mortem injuries. The injuries were three gunshot wounds and two incised wounds.

4. On 06.03.2021. sub-Inspector Hillary Duck along with other police officers apprehended a car after an informer told her that a vehicle, perceived to be stolen by the informer, would come from the direction of Strand Road. The person driving the car told sub-Inspector Hillary Duck that his name was Rambo Scott. When he was searched, the police recovered a .32 calibre pistol with four live cartridges in a seven shot magazine from the pocket of his trousers. The police arrested Rambo Scott.

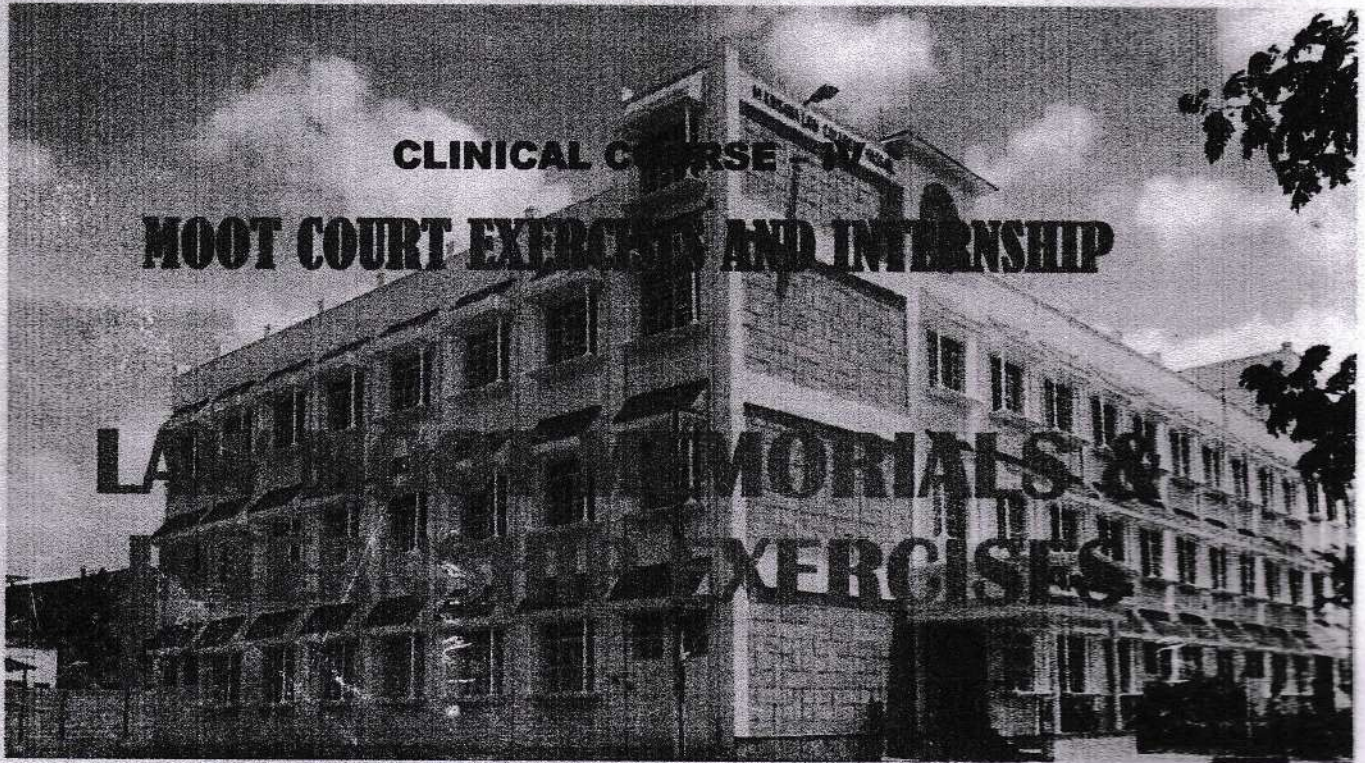




