MOOT COURT EXERCISE AND INTERNSHIP

Objectives:

This course is designed to hone advocacy skills in the students: Moot Courts are simulation exercises up to endow students with facility in preparation of written submissions and planning, organising and arguments in the given time so as to convince the presiding officer.

Students should familiarize themselves with the various stages of trail in civil and criminal cases. The student should be exposed to real court experience. Further they should imbibe the skills of client interview-moment may be planned to be part of the internship. Each student enrolled in 3 year course shall an internship for minimm 12 weeks (20 weeks for 5 year L.L.B. Course) during the entire course NGO, trail and appellate advocates, legal regulatory authorities, legistatures and parliament, other moments, market institutions, law firms, companies, local self government and other such bodies may stipulate. However, the Internship shall not be for a period of more than four weeks in an academic year.

Course Contents:

Most Court (30 marks)

Each student shall participate in at least 3 moot courts. Each Moot court exercise shall carry marks, which shall be devided as under:

- for oral advocacy 5 marks, and
- Written submission 5 marks.
- The students shall make written submission on behalf of the party for whom he makes oral advocacy as assigned by the course teacher.
- The written submissions for the three moot courts shall be neatly written on one side of the bond save papers and bound together with a certificate signed by the course teacher and principal to the that it is the bonafide work of the concerned student.
- The cover shall indicate the name of the examination, subject, seat number and the center code

Observation of Trail (30 marks)

- Each student shall attend trail in two cases on civil and one criminal in the course of last to three years.
- The Student shall maintain a record and enter the various steps observed during their attendance on different day in the court.
- 1.3 The record shall be neatly written on one side of the bond size paper and bound. It will carry a certificate by the course teacher and principal to the effect that it is the bonafide work of the concerned student.
- 1.4 The Record shall be valued for 30 marks.
- 1.5 The cover page shall indicate the name of the examination, subject, seat number and the center code number.

Client Interviewing (30 Marks)

Each students shall observe two session of the client interviewing at the Lawyer's Office/Legal Aid Office and record the proceedings in a diary, which shall carry 15 marks.

The Diaries shall be neatly written on one side of bond size papers and bound with a certificate 1.3 signed by the course teacher and the Principal to the effect that it is the bonafide work of the concerned student.

Viva (10 Marks)

At the end of the semester, the student shall appear for a viva voce, which shall carry 10 Marks.
