COURSE V : CLINICAL COURSE - IV : MOOT COURT EXERCISE AND INTERNSHIP

Objectives :

This course is designed to hone advocacy skills in the students : Moot Courts are simulation exercises geared up to endow students with facility in preparation of written submissions and planning, organising and marshalling arguments in the given time so as to convince the presiding officer.

This students should familiarize themselves with the various stages of trail in civil and criminal cases. They should be exposed to real court experience. Further they should imbibe the skills of client interviewing. This component may be planned to be part of the internship. Each student enrolled in 3 year course shall undergo an internship for minimm 12 weeks (20 weeks for 5 year L.L.B. Course) during the entire course under NGO, trail and appellate advocates, legal regulatory authorities, legistatures and parliament, other legal functionaries, market institutions, law firms, companies, local self government and other such bodies as the university may stipulate. However, the Internship shall not be for a period of more than four weeks continously in an academic year.
