- 1) Bino Joseph, a 26 year old man whose cerebral cortex was destroyed by lack of oxygen after an accident in 2020 is in permanent vegetative state at Gayatri Hospital in Bangalore. The doctors are certain that recovery was impossible and his medical expenses are more than ₹ 1000 per day.
- 2) Meanwhile, in December 2022 almost after 2 years to his accident, his younger sister Nancy, a 15 year old has a total kidney failure and upon having blood tests done, it was found that only Bino's kidney was compatible for a transplant. Bino had made a declaration prior to his accident by writing in his diary that he wanted to donate his organs.
- 3) Since, their daughter's life was in grave danger the parents of Bino requested the doctors to grant passive euthanasia to Bino and transplant his only kidney to his younger sister the further treatment

Statement of Jurisdiction

Article 32 of the constitution of India, 1949

Article 32. Remedies for enforcement of rights conferred by this Part.

- (1) The right to move the Supreme Court by appropriate proceedings for the enforcement of the rights conferred by this Part is guaranteed.
- (2) The Supreme Court shall have power to issue directions or orders or writs including writs in the nature, whichever may be appropriate, for the enforcement of any of the rights conferred by this Part.

- 1) On 26th May 2022 at about 10 am the appellants son who was 15 year old boy was rushed to the "ONP General Hospital" at Pune city by his neighbours for an suicide attempt.
- 2) The mother who is the appellant was informed and she came to hospital at about 10:30 am and was very anxious, worried, was losing temper very often. She was continuously blaming the boy's father for being irresponsible as she was the only parent to her child. Unfortunately the boy died in few hours.
- 3) On 30th May 2022, an article was published in the "Daily Mail" newspaper, the appellant came across the article and she read several examples, with holding the real names and one of the examples was very close to her son's incident. With the example the name of the hospital "ONP General Hospital" was also mentioned and the respondent had access to the hospital records.

- 4) The appellants colleagues, friends, relatives who were making phone calls for condolence but at the same time were mentioning about the newspaper article.
- 5) When the appellant resumed her office immediately on 1st June as she had lot of assignments to complete and meet the deadlines, her supervisor called her in his office and asked about the article. However he informed that her promotion and salary increment which was due is time being delayed further for six months and her performance will be evaluated.
- 6) Due to all this and hearing many discussions on the same issue by her colleagues, the appellant found painful, mentally and emotionally exhausting. The appellant was shocked to read the words in Sara's clinical note as the same words were used in the example of the newspaper article.

Statement of Facts


- 1) On 05/01/2022, Mrs. Osaka Cornell received the news of her husband's murder and death from station officer, Montauca Police Station. Mrs. Osaka Cornell lodged a complaint and F.I.R. NO. 13/2022 was filed under sections 302 and 201, Ordinance Penal Code, 1860. She also informed the police on description of her husband's dress at the time of death.
- 2) Inspector Michael Watson prepared the seizure memo of items recovered from the place of murder and the body was sent with constable for post-mortem. Dr. Larry John conducted the post-mortem of the body and found that the death of the deceased was a result of ante-mortem injuries. The injuries were three gunshots and two incised wounds.
- 3) On 06/03/2022, Sub-Inspector Hillary Duck along with other police officers, apprehended a car after an informer told her that a vehicle, perceived to be stolen by the

informer, would come from the direction of Strand Road. The police arrested the person driving the car named Rambo Scott and a .32 calibre pistol with four live cartridges were recovered by the police from him.

4) On 08/03/2022, the car was identified by Mrs Osaka and she produced a copy of registration certificate of the car and it was identified as the car of her deceased husband.

5) On 15/03/2022, the police recorded the confession statement of Rambo in which he mentioned the name of his friend Austin Baker and Austin's brother Simon Baker and stated that the car was left at his place by them stating that it is his car and left the home with a laptop. Rambo also stated that a blue sweater was left at his residence and when he went to Austin's place to return he got to know that the car belonged to the deceased Mr. Cornell and they had murdered him. The blue sweater was also recovered from Rambo's home and Mrs. Osaka identified the sweater and later on 22/03/2022 Rambo was produced before the Judicial

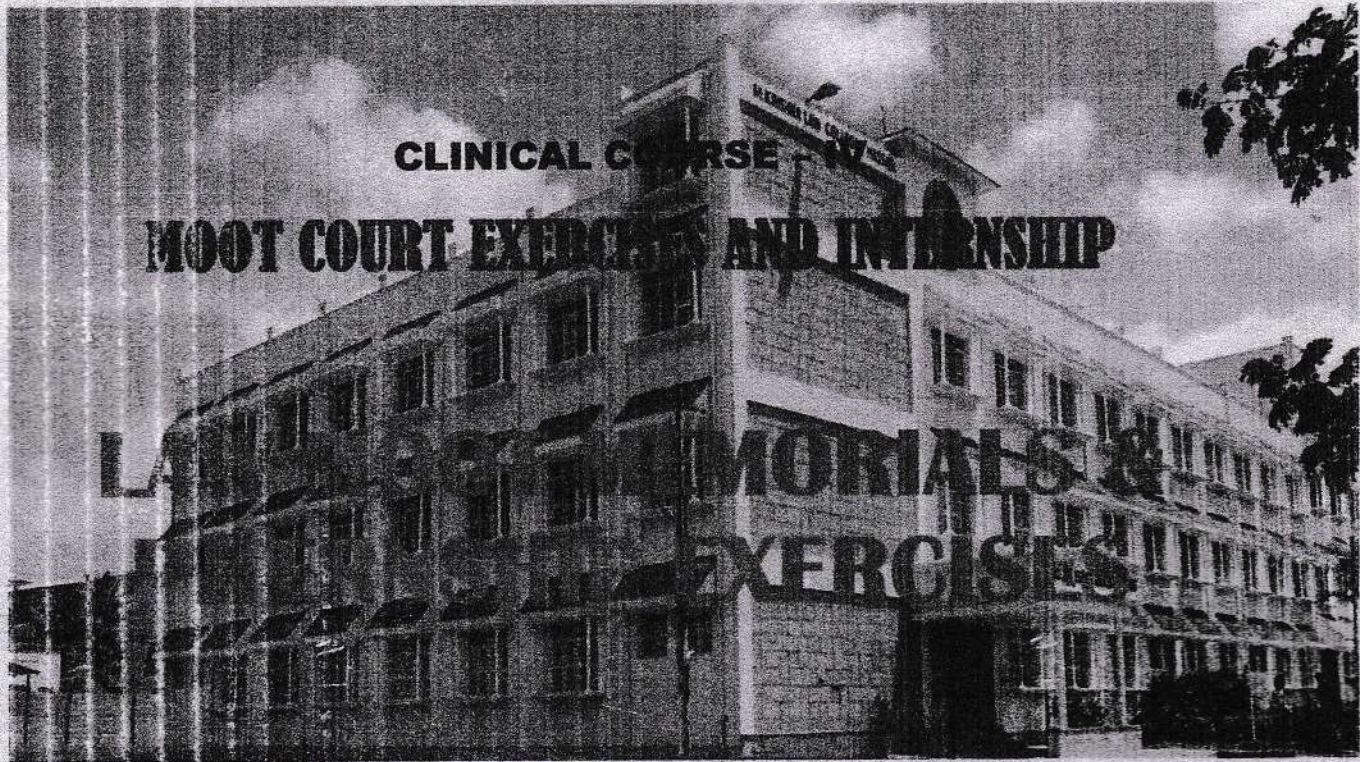


