4. That the trust shall provide opportunity to the students of the college to observe and study the activities of the trust.
5. The Law college shall provide the list of the students in advance by the principal to the Managing Trustee and the same shall be made at the supervision of the faculty of the college.

Cancellation / Ratification:


This MoU shall initially be in force for a period of 5 years with effect from the date of signing this MoU. Each party represents that in entering into this MoU it does not rely on any previous representations, whether express or implied or on any prior inducement or MoU of any kind or nature.

Execution:



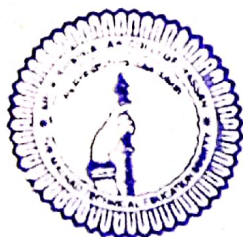
