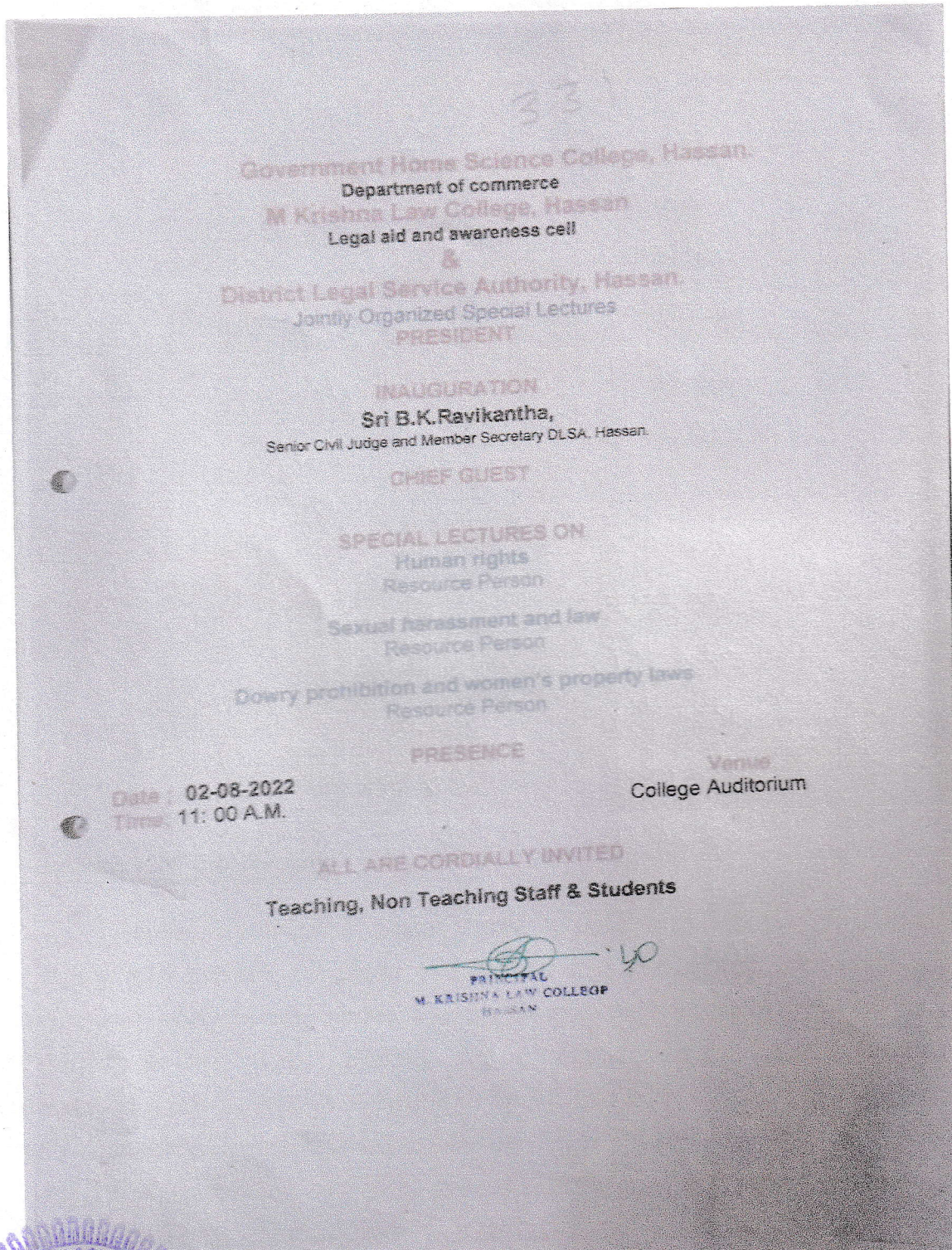


**Human Rights, Sexual Harrassment & Law, Dowry Prohibition and Women's Property Laws**
